Cooperativa Sociale Il Cenacolo, member of the syndicated associations group Consorzio Co&So, leading proponent of “Re-Build” project cofinanced by by Asylum Migration and Integration Fund 2014-2020, intends to select implementing organizations based in the country of origin, that will undertake the management and monitoring activities of Individual Reintegration Plans (PIR) of migrants who decide to leave Italy and voluntarily return to their country of origin

Eligible and recruitment process requirements

Activities:

- Feasibility check of the Individual Reintegration Plan (PIR) before departure, according to the economic opportunities in the Country of origin and information gathering about the applicant's network
- Identification of socio-economic reintegration opportunities according to the Reintegration Plan developed in Italy;
- Supply of the reintegration subsidy for goods and services, that is functional to the implementation of the Reintegration Plan;
- Orientation and support, if necessary, to reach and involve other local service providers.
- Support for PIR implementation and monitoring on site (at least two visits) and production of the reporting documentation (visits checklist and returnees contacts list constant update, reports of individual visits, final monitoring report, receipts of goods and services);
- Production, management and submission of financial documentation and report (receipts and invoices to evidence all expenditure of the subsidy in goods and services provided).

Eligible Countries: the activities listed above must be carried out in countries of origin that is in Mali, Nigeria, Gambia)

Duration: all the activities for the implementation and monitoring of the Individual Reintegration Plan will last at least six months for each returnee. The aforementioned activities shall be implemented by December 31st 2021 at the latest.

The signing of contract between Il Cenacolo SCS and the selected local organization will set the starting point of the activities.
